Agreement and Release of Liability

The Renter, on behalf of themselves and all guests, invitees, and participants, agrees to indemnify, defend, and hold harmless the Sutter Youth Organization (S.Y.O.), including its members, officers, employees, and volunteers, from and against any and all claims, demands, liabilities, losses, damages, judgments, costs, and expenses (including reasonable attorneys' fees) arising out of or related to the use of the Morehead Family Community Pool and its facilities.

This includes, but is not limited to, any claims for bodily injury, illness, death, or property damage resulting from or connected to the Renter's use of the premises, the conduct of the Renter or their guests, or any activities occurring during the rental period. The Renter further agrees to defend the S.Y.O., its members, officers, employees, and volunteers against any such claims, whether caused in whole or in part by the actions or omissions of the Renter or their guests.

Conditions of Use & Cleaning Requirements

- All rentals are on a first-come, first-serve basis.
- A completed contract and a \$100 deposit are required to book your rental. This is non-refundable if your party is cancelled.
- The security deposit will be subtracted from your total rental fees at the beginning of your party.
- The renter will be billed for any damages to the Sutter Youth Organization's property while renting the facility.
- The Sutter Youth Organization is not responsible for broken, lost, or stolen items.
- Renter must ensure all POOL RULES are followed by their guests.
- **Alcohol is NOT permitted in the pool facilities.**
- Glass is NOT permitted in the pool facilities.
- **Confetti of any kind is NOT permitted, this includes balloons with confetti inside them.**
- If feminine products are flushed down toilets, Roto-Rooter fees will be the responsibility of the renter.
- Parking areas must be clean. All litter, cigarette butts, etc. needs to be disposed of properly.
- No staples permitted. Only painter's tape is allowed on walls, tables, and chairs. All tape must be completely removed.
- Vehicles are not permitted on the lawn.
- **A \$250 cleaning fee will be charged if restrooms are found excessively dirty after the rental period. This includes, but is not limited to:**
 - **No trash on the floors or walls.**
 - **Toilets, toilet seats, sinks, and drains must be free of debris.**
 - **Overall cleanliness must be maintained to avoid any additional cleaning charges.**
